Instructions for Submission of Management Quota Application Forms for 2026 F.Y.U.G.P. Admissions in Sree Vivekananda College under Cochin Devaswom Board Management :-

1. The Management Quota Applications for U.G. programme admission in Sree Vivekananda College under Cochin Devaswom Board for the Academic Year 2026-2027 shall be submitted via **link given for Google form in the college website address given below, <https://www.svcollege.ac.in/>**
2. Any other form of application submission shall not be entertained for 2026 U.G. management quota admissions of this college.
3. The Google form link for submitting management quota applications for U.G. admission shall be opened from **15/06/2026 morning 11.00.AM to 26/06/2026 evening 5.00 PM.**
4. The applicant has to pay an amount of **Rs.300/- as Application Fee for submission of Google form** under Management Quota in the below given **bank account details :-**

5. An applicant can give **maximum 3 preferences among the Four U.G. Programmes of this college in a single application form submission upon proof of payment of Rs. 300/- .**
6. If any applicant want to apply for more than 3 U.G. programmes the applicant shall submit separate application form from another e-mail id upon fresh payment of Rs. 300/- for that submission. Both these submissions shall have different Transaction IDs.
7. The applicant shall have **CAP - ID registration for 2026 FYUGP admission.**
8. **Applicants shall be from HINDU religion only.**
9. **Applicant shall have atleast 50 % marks in the Qualifying Exam.**
10. **The Applicant should have opted/applied for U.G. Programmes offered by Sree Vivekananda College at Calicut University CAP registration.**
11. It is mandate that Google form submission require uploading of **Proof of Payment of Application fee Rs. 300/- for management quota application submission, Copy of SSLC, Copy of Mark list of Qualifying Exam (Plus Two/Equivalent), Proof of UG-CAP Reg. Form, Proof of Valuable Service Quota if the applicant submits under this category, Proof of Staff Quota-Cochin Devaswom if submits under this category.**
12. **No edit option shall be available to the applicant after final submission.**
13. **All the necessary certificates and supporting documents with originals shall be submitted at the management office at the time of verification for admission.**
14. **The seat under management quota shall be filled by the Cochin Devaswom Board management from among the applicants of their preferences subject to the eligibility and merit.**
